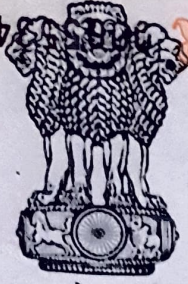

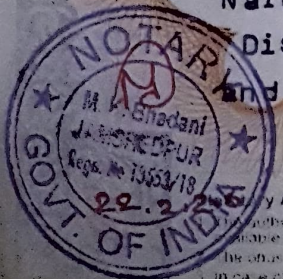

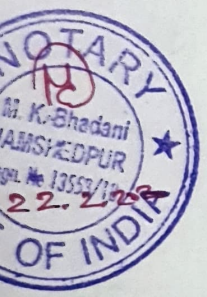

13. That the school will not coerce any student/ parent to buy books/ stationery/ uniform from any particular shop.

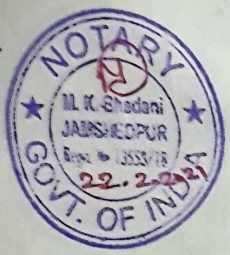
14. That the school shall strive to make efforts for conservation of environment.
